**Briefing Note #3: Ontario's proposed 'Digital ID'**

#### **Ontario**:

Ontario first announced its plan for a 'Digital ID' October 2020 as part of Ontario Onwards: Ontario's Action Plan for a People-Focused Government. It was initially described as a 'digital wallet' on a smartphone or computer containing information like that found on provincial health cards, driver's licence, and birth certificate.

Promised for late 2021, the 'Digital ID' has yet to be launched but was expected to be launched by Fall 2022. The Digital ID is a big part of Ontario's goal of 'Building a Digital Ontario'.

Ontario claims the 'Digital ID' will be <u>convenient</u>, <u>secure</u>, <u>privacy-preserving</u>, <u>in your control</u>, <u>and voluntary</u>. It could be used for many purposes requiring reliable personal identification – like opening a bank account, making age-sensitive purchases, and accessing and using vaccination records.

As of December 20, 2020, the Ontario government had provided no updates (since November 2021) on its digital ID program.

Expected late 2021, unexpectedly delayed to Fall of 2022, with no updates on any future plans discovered <u>as of February 12, 2023</u>.

General information: While there are obvious benefits of a reliable system of personal identification, it is all-too-easy to see how an initially privacy-preserving and voluntary technology could morph quickly into a mandatory system enabling 24/7 surveillance and control. Digital IDs could easily be exploited to erode fundamental rights and freedoms.
